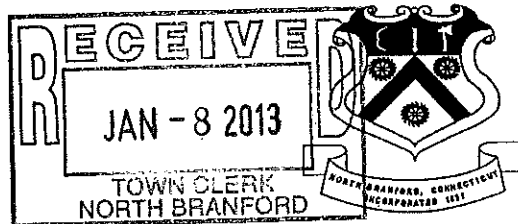

Solid Waste – Nothing to report


