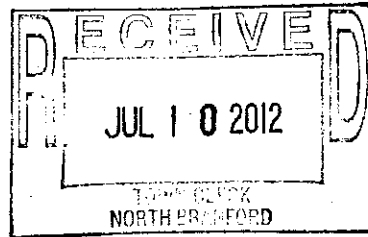

**7. Other Business:**


- Appointments – 3 vacancies and reappointments; still need more volunteers for this committee.
